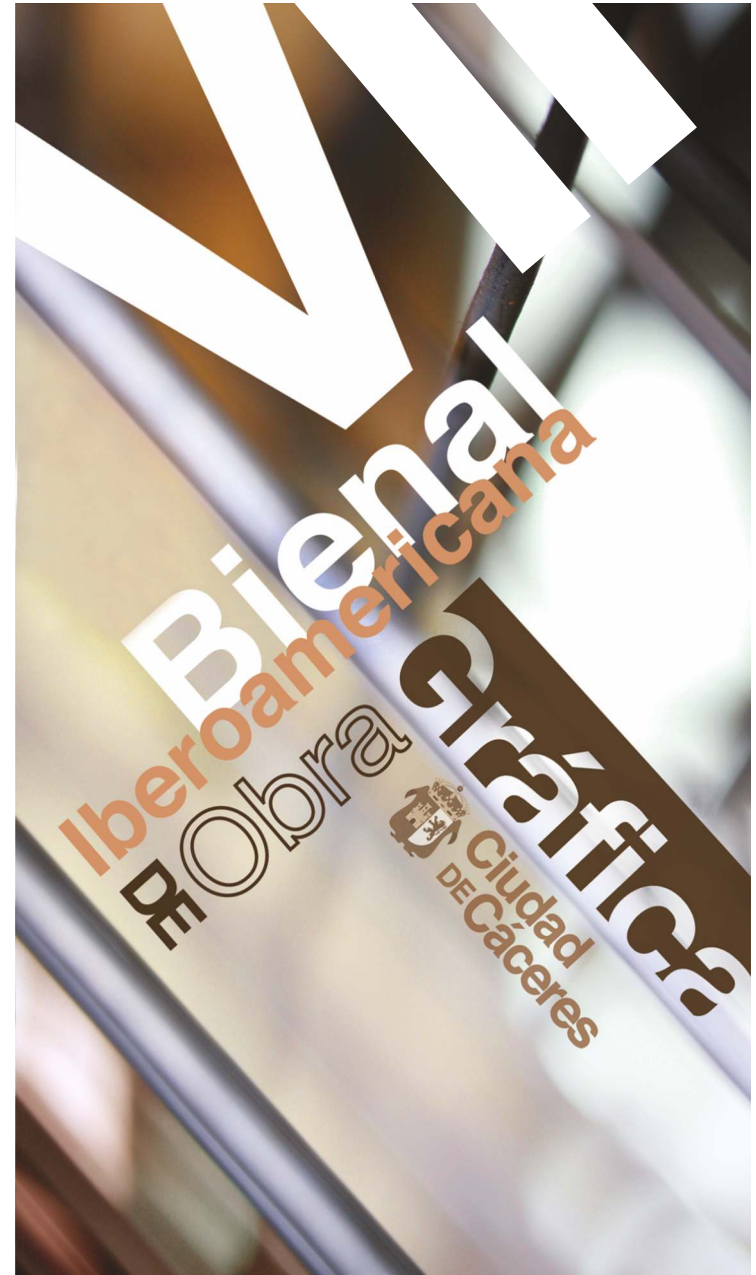

Cáceres City Hall convened the **VII Biennial of Latin American Graphic Work** "Ciudad de Cáceres" which will be ruled by this articles:

BASES

Article 1

Both spanish artists and artists from the international community will be able to take part in the contest.

Article 2

The following prizes will be granted:

- First prize: Endowed with eight thousand euros (8.000€)
- Second prize: Endowed with three thousand euros (3.000€).All included taxes

Article 3

The artist will send unpublished and original works. Works with more than one year old, copies or anonymous will not be admitted. Neither will be those that have taken part in other contests or those that have been edited.

Article 4

The prices will be granted to graphic works that have been obtained by any of the different multiple printed images procedures -engraving, silk-screen, printing, additives techniques, electrographics, digital, etc...

All graphic art techniques will be admitted, alone or in combination

Article 5

Participants will be able to enroll two works maximum. The topic and the trend is in the opinion of the participants.

PERIOD, PLACE, AND FORM OR PRESENTATION

Article 6

The period of presentation and reception of the works will begin the next day after the publication of the rules of the contest in the region's official bulletin, and it will end at 14:00h on June 20, 2017. The works will be sent and delivered personally to the cultural department of Cáceres's City Hall, located at Plaza de la Concepción, Number: 2, Postal Code: 10003, Cáceres. Those who send the material through a specialized courier company will be registred as delivery date the date indicated by the corresponding stamp. The same limits and requirements will be applied.The cultural department of Cáceres's City Hall will be extremely careful with the works received, but it will not take responsibility of losses, thefts, breaks or damages of the works that may result from the transport or from unforeseeable accidents.

Article 7

The artists will have to take charge of the packaging, transport and insurance of their work. The organization will not take care of any expenses of any nature, neither will pick up any work at personal homes, transport terminals, etc... The artists will send their work on a flexible support and will present a document declaring that it is for a temporal exhibition; and they also should have, if necessary, the export permit of the original country. Also, by separate mail, they must send a copy of the documents to the organization and communicate the shipping of the works, providing the personal data of the author.

Article 8

The artist will stick a label with the name and the surname of the author, address, work title, process and size. The documentation and the registration form, duly completed, must be sent in another envelope and outside the packaging. As well as a copy of the ID or any other document that proves his/her identity, a brief resume and a slide or CD with a color image of the work presented.

Article 9

The organization will inform the artists if the works that they have sent is admitted or rejected.

Article 10

The jury for the selection and the prize, which will designated by the mayor of Cáceres, will be composed of people with known artistic and intellectual experience. The prizes will be decided by simple majority vote of the jury. The jury's ruling will be final.

Article 11

The jury's ruling will be announced during an awards ceremony and during the exhibition of the selected works.

Article 12

The award winning artists will have to submit two more pictures of the awarded works, which together with these, will become property of the Cáceres's City Hall and they will be part of its art collection.

Article 13

From all of the works received the jury will make a selection for the exhibition. Likewise, the organization understands the artists give their permission for their names citation and for the reproduction of their work in the exhibition catalogue.

Article 14

The works - admitted or not- will be removed within thirty days following the end of the exhibition, no exceptions

Article 15

The participation of the artists in the current edition of the contest implies the acceptance of all of the terms and bases and the additional rules.
